# LEGAL PROVISIONS "Gimme 5" – Amsterdam The Style Outlets

### 1 Organizer

The companies Neptune Amsterdam B.V. (VAT No. 53569946), with registered office at Herikerbergweg 238, 1101 CM Amsterdam, and Neinver, S.A.U. (VAT No. A31038136), Avenida Pío XII 44, 2ª Planta, 28016 Madrid (hereinafter jointly "the Organizers"), organize the promotion "GIMME 5 AT AMSTERDAM THE STYLE OUTLETS" (the "Promotion"). This promotion is intended to stimulate purchases at Amsterdam The Style Outlets. Participants who submit five receipts from the same day will immediately receive a surprise merchandising gift and will, every two weeks, have a chance to win a € 50 gift card (total prize pool € 300).

Amsterdam The Style Outlets and Neinver are hereinafter referred to as "the Organizers."

### 2 Purpose of these Legal Provisions

These legal provisions (the "Legal Provisions") govern the terms and conditions of participation in the Promotion and must be accepted and complied with by all Participants.

## 3 Participants

- 3.1. The Promotion is open to all natural persons who:
  - are 18 years of age or older;
  - have full legal capacity;
  - participate from within the Netherlands;
- are not employees, interns or contractors of the Organizers or any of their affiliated entities, nor related to them by consanguinity or affinity up to the third degree;
- do not commit fraud or otherwise hinder the proper conduct of the Promotion.

3.2. Registration or account creation is not required. Participation implies unconditional acceptance of these Terms.

# **4 Objective of the Promotion**

The Promotion aims to increase footfall and spending at Amsterdam The Style Outlets during the period from 30 June through 30 September 2025.

#### 5 Duration

Participation is possible daily from 10:00 to 18:00 or 10:00 to 20:00, from 30 June to 30 September 2025, or while gift stock lasts. No submissions will be accepted after 30 September at 22:00.

#### **6 Prizes**

- 6.1. Immediate gift: for each set of five receipts (no minimum amount required, valid for purchases at stores and restaurants within Amsterdam The Style Outlets) submitted in one visit, the Participant will immediately receive a surprise merchandising gift.
- 6.2. Bi-weekly draw: every two weeks, among all sets submitted during that period, one € 50 gift card will be awarded, up to a total prize pot of € 300.
- 6.3. Gift cards are redeemable only at Amsterdam The Style Outlets (excluding any exceptions noted on issuance), are non-transferable, and cannot be exchanged for cash. Each card is valid for two years from the date of issue.

### 7 Mechanics & Participation Conditions

7.1. Participants must go to the Information Point at the main entrance (SugarCity Ring 1, 1165 PB Halfweg).

- 7.2. They must present five receipts from the same day (they may repeat as often as they like, but each submission must consist of a new set of five).
- 7.3. Staff will stamp or register each submission and hand over the surprise gift immediately.
- 7.4. A draw is held every two weeks; winners will be notified by e-mail or phone and may collect their € 50 gift card at the Information Point.
- 7.5. Maximum one merchandising gift per person, per submission; maximum one gift card per person per draw period. The gift card may be collected up to one month after award.

### 8 Liability

The Organizers shall not be liable for:

- any use or misuse of the gift card after acceptance;
- errors in contact details provided by Participants;
- delays or cancellations beyond their control (force majeure).

The Organizers reserve the right to modify, postpone, extend or shorten the Promotion if necessary for its proper execution.

#### 9 Fraud

In case of suspected irregularities or fraud, the Organizers may exclude Participants and, if necessary, report to the competent authorities.

#### 10 Use of Personal Data

Neptune Amsterdam B.V. is responsible for processing Participants' personal data solely for the execution of this Promotion. The legal basis is the performance of the contract with the Participant. Data will be retained as long as necessary for the Promotion and applicable statutory retention periods. Participants may exercise their rights of access, rectification, erasure, restriction, data portability and withdrawal of consent via
